

2.	Date of Inspection of Scrap Items	Scrap items can be inspected at the O/o the Director of Income Tax(I&CI), 4 <sup>th</sup> Floor/Basement, Central Revenue Building, Sector-17E, Chandigarh on 24.03.2022 (from 11:00 AM to 04:00 PM).

### 3. Terms and Conditions and General Information:

1. The bidder should be registered with Central/State Pollution Control Board and should have the valid license in case of e-Waste materials. A copy of the License should be enclosed along with the offer. Non-submission of a valid license will render the tender as invalid and will be rejected.
2. Quotations are to be submitted in sealed covers in the prescribed proforma as Annexure-II super subscribing the details of quotation and should be submitted within the last date and time specified above.
3. GST to be paid extra, as applicable, at the time of taking out the materials.
4. The sale be on "AS IS WHERE BASIS IS" (Both Lot wise and Item wise) bidders will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/items proposed to be auctioned.
5. It is responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.
6. Bid received within the due date only will be entertained.
7. The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bid.
8. The quotation shall be written legibly and be free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory. Rates should be written both in words and in figures.
9. Bidder cannot withdraw their offer once it is submitted.
10. No enquiry of the bidder shall be entertained once the material is lifted by them.
11. All labour, tools and equipments for loading the items from the O/o the DIT(I&CI), Central Revenue Building, Sector-17E, Chandigarh site to buyer's trucks/vehicles with all leads, lifts etc., shall be the cost of the buyer.
12. Interested bidder(s) must submit an EMD of Rs. 2,000/- (Rupees Two Thousand Only) in form of Demand Draft/Banker's Cheque payable at State Bank of India, Chandigarh – in favour of "ZAO' CBDT" payable at Chandigarh. EMD shall be returned to the unsuccessful bidder(s) whereas for successful bidder must deposit the amount obtained by deducting EMD from contract amount at the time of taking away the materials. No interest will be payable on EMD.
13. The intending bidder have to deposit Application fee of Rs.200/-(Non refundable) by the way of Demand Draft/Bankers cheque payable at State Bank of India, Chandigarh in favour of "ZAO' CBDT" payable at Chandigarh before participating in the auction.
14. The successful bidder with Highest Bid will be issued a Sale Order and shall have to make payment in the form of Demand Draft with the name of Director of Income Tax(I&CI), Chandigarh or submitted by Cheque at the O/o the DIT(I&CI), Chandigarh for the quantity at the contract rate plus taxes.
