
Kindly refer to the subject cited above.

02. As you are aware that ITBA application was rolled out in 2016-17 and thereafter a lot of changes have been incorporated in the ITBA application along with sea change in the role of the Department. Many new functions have been introduced in the Department with introduction of Faceless Assessments and Faceless Appeals.

03. With this change, the ITBA application has also been revamped and other applications like Project insight, latest e-filing etc have been launched to cater to the latest function of the Department. Due to this, the requirement of computers to run these applications has also changed. Day to day, it is becoming difficult for the officers to work on old/obsolete PCs. These old/obsolete PCs require urgent replacement with the latest configuration of the Computers. This office proposes to change these PCs in the field formations in a phased manner.

I have been directed that to assess the requirement of PCs in the field formation, a consolidated report (PCIT/CIT-wise) in the following proforma is required, which may kindly be sent at Chandigarh.jd.systems@incometax.gov.in by 14.10.2021(5 PM). FMS engineers have been directed to help in preparing the above reports.
