**Terms and Conditions:-**

1. The intending bidders have to deposit EMD of Rs. 15000/- (rupees fifteen thousand only) by way of Demand Draft/Banker's cheque payable at State Bank of India, Ferozepur-in favour of "ZAO CBDT" payable at Amritsar before participating in the auction. No interest will be payable on EMD.
2. The intending bidder have to deposit application fee of Rs. 200/- (Non Refundable) by the way of demand Draft/Bankers cheque payable

at State Bank of India, Ferozepur in favour of "ZAO, CBDT" payable at Amritsar before participating in the auction.

3. After inspection of items bidder should quote a price or an amount which he is ready to pay for the scrap offered for sale in a sealed bid.
4. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf. A copy of such authority should be enclosed along with the bid.
5. Bid forms are not transferable.
6. The EMD of unsuccessful bidders will be refunded.
7. Bidder(s) can inspect the articles/items between 10.AM to 3.00 PM, in the above mentioned address on 01.11.2021 in regard to the conditions, quality etc. of the articles items and satisfy themselves before submitting their offer by the date and time specified
8. Any tax is leviable shall be Paid by the successful bidder.
9. All articles/ items will be sold on "AS IS WHERE IS BASIS"(Both lot wise and item wise) bidder will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles/items proposed to be auctioned.
10. The successful bidder will be required to make full payment of bid by way of submitted a Demand Draft/Banker's Cheque payable at State Bank of India , Ferozepur in favour of "ZAO, CBDT" payable at Amritsar by 02.00 PM on 02.11.2021 after the finalization of the bid. The demand Draft/ Banker's cheque is to be submitted to the Income Tax officer, Feozepur.
11. The successful bidder will have to lift the articles/ items in his own cost, risk and arrangement by 06 PM on 02.11.2021 after depositing the full amount of payment of the bid otherwise the EMD will be confiscated.
12. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of this office and no delivery would be effected by this officer to any person or persons(s) other than the bidder whose name/ names are mentioned in the order.
13. The condemned items/articles will be sold in one lot. The bidders shall quote the rate for one lot i.e. after totaling the lot wise and item wise list of the articles enclosed alongwith this tender document.
14. The bidder who has quoted maximum price, subject to the condition that it should be more than the reserve price fixed by this office, shall be considered as successful bidder.

15. Income tax employees and their families are not allowed to participate in the auction.
16. Scaled Envelopes should contain the tender form, application fee IIMD and the cover should be super scribed as "Tender for Disposal of condemned items/articles of the O/o Chief Commissioner of Income Tax" and dropped in person in the tender box on or before 01.11.2021 till 10:00 AM kept for the purpose in Income Tax Office Ferozepur (during the working hours only. This office shall not be responsible for any delay.
17. The tender received without Tender Fee, EMD amount by way of DD or Bankers Cheque payable at ZAO, CBDT payable at Amritsar will be considered at all.
18. No bid shall be accepted after the due date and time. If the due date happens to be a holiday the bid due date will be next working day at the same time notified as above.
19. Bids will be opened on the same day i.e. 01.11.2021 at 2:30 p.m. If the opening date happens to be a holiday the bid shall be opened in the next working day of the same time in the administrative block in Income Tax Office, Ferozepur.
20. The auction shall be subject to the Indian laws and jurisdiction of the Courts located in Ferozepur.
21. The undersigned reserves the right to postpone the date of opening or accept or reject any or all the bids without assigning any reason at any stage.
22. Paper scrap is to be disposed of in a paper shredder in presence and supervision of Officials of Income Tax deputed for the purpose.
