3. Terms and conditions of General information:

- (i) The bidder should be registered with Central/State Pollution Board and should have the valid license in case of e-waste materials. A copy of the License should be enclosed alongwith the offer. Non-submission of a valid license will render the tender as invalid and will be rejected.
- (ii) Quotations are to be submitted in sealed covers in the prescribed performa as Annexure-II super subscribing the details of quotation and should be submitted within the last date and time specified above.
- (iii) GST to be paid extra, as applicable, at the time of taking out the materials.
- (iv) The sale to be on "AS IS WHERE BASIS IS" (Both Lot wise and Item wise) bidders will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quality of the articles/items proposed to be auctioned.
- (v) It is responsibility of the bidder to assess the items properly before quoting. No further claims will be entertained after opening of the bids.
- (vi) Bid received within the due date only will be entertained.
- (vii) The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bid.
- (viii) The quotation should be written legibly and be free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory. (Rates should be written both in words and in figures.

Bidders cannot withdraw their offer once it is submitted.

No enquiry of the bidder should be entertained once the material is lifted by them.

All labour, tools and equipments for loading the items from the Drawing & Disabusing Officer, O/o The Pr. Commissioner of Income tax (AU)-1 Aayakar Bhawan, Rail head Complex, Jammu site to buyer's trucks/vehicles with all leads, lifts etc., shall be the cost of the buyer.

Interested bidder(s) must submit an EMD of Rs. 2,000/- (Rupees Two Thousand Only) in form of demand Draft/Banker's Cheque payable at State Bank of India, in favour of "ZAO' CBDT" payable at Jammu DD shall be returned to the unsuccessful bidder(s) whereas for successful bidder must deposit the amount retained by deducting EMD from contract amount at the time of taking away the materials. No interest will be payable on EMD.

- (i) The intending bidder have to deposit Application fee of Rs. 200/- (Non refundable) by the way of demand Draft/Bankers cheque in favour of "ZAO' CBDT" payable at Jammu before participating in the auction.
- (ii) The successful bidder with Highest Bid Will issued a Sale Order and shall have to make payment in the form of Demand Draft or submitted by Cheque at the "ZAO' CBDT" payable at Jammu for the quantity of the contract rate plus taxes.
- (iii) The quantity of the items indicated in the list is approximate and sale will be effected at actual at the time of taking delivery.
- (iv) The bidder should take delivery of the items within 07 days from the date of Sale Order.
- (v) The bidder will not be permitted to short out the materials. The entire lot should be cleared as detected by the Income Tax Authority.
- (vi) Removal and transportation of materials should be done only during working hours of Jammu No material will be allowed to go out on Holidays.
- (vii) The materials shall be collected in trucks/vehicles licensed to carry such products. The buyer will arrange to remove the materials sold to him and clean the site within the stipulated period mentioned in very period, if not then the EMD will be forfeit.
- (viii) No other material should be removed from the site.
- (ix) The bidders are required to indicate their PAN in their offer since it has been made mandatory by the Income Tax Department reserves the right to divide/split the orders between more than one qualified bidders.
