Terms and conditions: -

1. The intending bidders have to deposit EMD of Rs. 1,000/- (Rupees One thousand only) by way of Demand Draft/Banker's Cheque payable at State Bank of India, Khanna -in favour of "ZAO, CBDT" payable at Ludhiana before participating in the auction. No interest will be payable on EMD.
2. The intending bidder have to deposit Application fee of Rs.200/-(Non refundable) by the way of Demand Draft/Bankers cheque payable at State Bank of India, Khanna in favour of "ZAO, CBDT" payable at Ludhiana before participating in the auction.
3. After inspection of items bidder should quote a price or an amount which he/she is ready to pay for the scrap offered for sale in a sealed bid.

4. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf. A copy of such authority should be enclosed along with the bid.
5. Bid forms are not transferable.
6. The EMD of unsuccessful bidders will be refunded.
7. Bidder(s) can inspect the articles/items between 10:00 a.m. to 3:00 p.m. in the above mentioned address on 11/11/2021 in regard to the conditions, quality etc. of the articles/items and satisfy themselves before submitting their offer by the date and time specified.
8. Any tax is leviable shall be paid by the successful bidder.
9. All articles/items will be sold on 'AS IS WHEER IS BASIS" (Both Lot wise and Item wise) bidders will be deemed to have been on the clear understanding that they have satisfied themselves full in regard to the conditions, quantity and quality of the articles/items proposed to be auctioned.
10. The successful bidder will be required to make full payment of bid by way of submitting a Demand Draft/Banker's Cheque payable at State Bank of India, Khanna – in favour of "ZAO'CBDT" payable at Ludhiana by 11:00 a.m. on 08/11/2021 after the finalization of the bid. The Demand Draft/Banker's Cheque is to be submitted to the ITO (ReFAC) AU1(4)(2) Khanna O/o Addl. Commissioner of Income Tax, (ReFAC) AU-1(4) Jammu at Khanna.
11. The successful bidder will have to lift the articles/items at his own cost, risk and arrangement by 6:00 p.m. on 15/11/2021 after depositing the full amount of payment of the bid otherwise the EMD will be confiscated.
12. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of the office and no delivery would be affected by this office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
13. The condemned items/articles will be sold in one lot. The bidders shall quote the rate for one lot i.e. after totaling the lot wise and item wise list of the articles enclosed along with this tender document.
14. The bidder who has quoted maximum price, subject to the condition that it should be more than the reserve price fixed by this office, shall be considered as successful bidder.
15. Income Tax employees and their families are not allowed to participate in the auction.
16. Sealed envelopes should contain the tender form, application fee, EMD and the cover should be super scribed as "Tender for Disposal of Condemned items/articles of the O/o Addl. Commissioner of Income Tax" and dropped in person in the tender box on or before 12/11/2021 till 12:00 noon kept for the purpose in Room of the O/o Dy. Commissioner of Income Tax (ReFAC) AU-1(4)(1), Jammu at Khanna, Improvement Trust Building, G.T.Road, Khanna (during the working hours only. This office shall not be responsible for any delay).

17. The tender received without Tender Fee, EMD amount by way of DD or Banker Cheque payable at ZAO, CDBT payable at Ludhiana will not be considered at all.
18. No bid shall be accepted after the due date and time. If the due date happens to be a holiday the bid due date will be next working day at the same time notified as above.
