TERMS AND CONDITIONS

- 1. All services shall be performed by persons qualified and skilled in performing such services as per the eligibility criteria indicated for the category.
- 2. The persons supplied by the Agency should not have any adverse Police records/criminal cases against them. The agency should make adequate enquiries about the character and antecedents of the person whom they are recommending. The character and antecedents of each personnel of the service provider will be got verified by the service provider before their deployment after investigation by the local police, collecting proof of identify like driving license/bank account details previous work experience, proof of residence and recent photograph and a certification to this effect submitted to the Directorate. The Firm Agency will not charge any registration fee from each new contact (Daily wages) employee at the time of initial engagement.
- 3. The service provider will also ensure that the personnel deployed are medically fit and will keep in record a certificate of their medical fitness.
- 4. The Service Provider shall withdraw such employees who are not found suitable by the Deputy Commissioner of Income Tax (International Taxation), Gurugram for any reasons (International Taxation), Gurugram.
- 5. The service provider shall engage necessary persons as required by this Directorate from time to time. The said persons engaged by the service provider shall be the employees of the service provider and it shall be the duty of the service provider to pay their salary every month through ECS and provide a proof of doing so to the Directorate. The Company/Firm Agency will provide proof of receipt of wages by the workers before the end of each month. There is no Master & Servant relationship between the employees of the service provider and the Deputy Commissioner of Income Tax (International claim any absorption in the Deputy Commissioner of Income Tax (International Taxation), Gurugram, on any ground whatsoever.
- 6. The service provider's personnel's shall not. Claim any benefit/compensation/absorption/regularization of services from/ in Deputy Commissioner of Income Tax (International Taxation), Gurugram under the provision of Industrial Disputes Act.1947 to this effect shall be submitted by the service provider to the Deputy Commissioner of Income Tax (International Taxation), Gurugram
- 7. The service providers personnel shall not divulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements, administrative/organisational matters as all these matters are of confidential/secret nature.
- 8. The service provider's personnel should be polite, cordial positive and efficient, while handling the assigned work and their actions shall promote goodwill and enhance the image of O/o the Deputy Commissioner of Income Tax (International Taxation),

- Gurugram. The service provider shall be responsible for any act of indiscipline on the part of persons deployed by the Agency.
- 9. That the persons deputed shall not be below the age of 18 years and they shall not interfere with the duties of the employees of the Deputy Commissioner of Income Tax (International Taxation), Gurugram.
- 10. The Deputy Commissioner of Income Tax (International Taxation), Gurugram may require the service provider to remove from the office, any person or persons, employed to any other reason whatsoever. The service provider shall, forthwith comply with such direction and shall replace such person immediately
- 11. The service provider has to provide Photo identity Cards to the persons deployed by them for carrying out the work. These cards are to be constantly displayed by their persons & their loss reported immediately.
- 12. The service provide shall ensure proper conduct of their persons in office premises and enforce prohibition of consumption of alcoholic drinks, paan, smoking, loitering without work etc.
- 13. The transportation, food, medical and other statutory requirements in respect of each personnel of the service provider shall be the responsibility of the service provider.
- 14. Working hours for Data Entry Operators would normally be 8 ½ hours per day from 9.30 AM to 6.00 PM during working days including half an hour lunch break in between and for Security Guards, it would be in three shifts of 8 hours each in a day. However, in Saturday, Sunday and other gazette holidays, if required. They may be paid extra wages as per the rates approved.
- 15. That the agency will be wholly and exclusively responsible for payment of wages to the persons engaged by it in compliance of all the statutory obligations under all related legislation as applicable to it from time to time including Minimum Wages Act, Employees Provident Fund Act, ESI Act etc. and the Deputy Commissioner of Income provider for any expenditure whatsoever on the persons employed by the agency on EPF, ESI of its employees engaged in the Deputy Commissioner of Income Tax (International Taxation), Gurugram on monthly basis, along with bill submitted by them.
- 16. The service provider will submit the bill, in triplicate in respect of a particular month in the first week of the next month along with copies of receipts towards EPF/ESI/Services will be released by the third week of the following month after deduction of taxes deductible at source under the laws in force.
- 17. Payments to the service provider would be strictly on certification by the officer with attendance certified as per the bill preferred by the service provider.

 18. No wage/remuneration in the service provider.
- 18. No wage/remuneration will be paid to any person for the days of absence from duty.

- 19. The service provider will have to provide the required number of additional persons for a shorter period also, In case of any exigencies, as per the requirement of this office i.e. Deputy Commissioner of Income Tax (International Taxation), Gurugram.
- 20. The service provider shall provide a substitute well in advance if there is any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the service provider.
- 21. The service provider shall be contactable at all times and message sent by phone/e-mail/whatsapp/Special Messenger from Deputy Commissioner of Income Tax (International Taxation), Gurugram to the service provider shall be acknowledged immediately on receipt, on the same day. The service provider shall strictly observe the instruction issued by the Deputy Commissioner of Income Tax (International Taxation), Gurugram in fulfillment of the contract from time to time.
- 22. The Deputy Commissioner of Income Tax (International Taxation), Gurugram shall not be liable for any loss, damage, theft burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the service provider.
- 23. That the agency on its part and through its own resources shall ensure that the goods, materials and equipment's etc. are not damaged in the process of carrying out the services undertaken by it and shall be responsible for acts of commission and omission on part of its employees, etc. if the Deputy Commissioner of Income Tax (International Taxation), Gurugram suffers any loss or damage on account of negligence, default or theft on the part of the employees/agents of the agency, then the agency shall be liable to reimburse to the Deputy Commissioner of Income Tax (International Taxation), Gurugram for the same. The agency shall keep the Deputy Commissioner of Income Tax (International Taxation), Gurugram fully indemnified against any such loss or damage.
- 24. The Deputy Commissioner of Income Tax (International Taxation), Gurugram shall maintain an attendance registers in respect of the staff deployed by the agency on the basis of which wages/remuneration will be decided in respect of the staff at the approved rates.
- 25. The successful bidder shall furnish a performance Security Deposit of Rs. 10,000/- in the form of Fixed Deposit Receipt from a commercial bank/bank guarantee from a commercial bank in any acceptable form, safeguarding the interest of the Deputy Commissioner of Income Tax (International Taxation), Gurugram. The security deposit shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the service provider. The security deposit will be forfeited, in case the supply of manpower is delayed beyond the period stipulated by the Deputy Commissioner of Income Tax (International Taxation), Gurugram or noncompliance of theterms of agreement by the service provider or frequent absence from duty/ misconducton the part of manpower supplied by the Agency.
- 26. The successful bidder will enter into an agreement with this Directorate for supply of suitable and qualified manpower as per requirement of this Directorate on these terms and conditions. The agreement will be valid for a period of 12 months from the date of contract and shall continue to be in force in the same manner, unless terminated in writing. The charges quoted by the agency (SI.No-3 of Annexure, III) shall be fixed for a period of 12 months and no request for any change/modification shall be entertained

before expiry of the period of 12 months. However, in case the contact has been given at minimum wages, the minimum wages will be revised so that the same is not less than the minimum wages decided by the Government of Haryana for Gurugram from time to time. The contract will be awarded @ D.C Rate fixed from time to time. The service charge will be awarded as per the minimum quoted rate.

- 27. The service provider shall not assign, transfer, pledge or sub contract the performance of services without the prior written consent of this Directorate.
- 28. The agency shall disburse the monthly salary of the workers before 7th Day of the succeeding month.
- 29. The agreement can be terminated advance. If the agency fails to give one month's notice in writing for termination of the Agreement then one month wages Deputy Commissioner of Income Tax (International Taxation), Gurugram shall be
- 30. On the expiry of the agreement as mentioned above, the agency will withdraw all its personnel and clear their accounts by paying them all their legal dues. In case of any personnel of the agency it shall be the entire responsibility of the agency to pay and settle the same,
- 31. In the event, if any dispute arises touching any of the clauses of the agreement, the matter will be referred to the Deputy Commissioner of Income Tax (International Taxation), Gurugram whose decision shall be binding on both the parties.
- 32. The Agency shall be responsible for faithful compliance of the terms and conditions of this agreement. Failure of it will attract forfeiture of outstanding dues as well as the their cost and risk, during the remaining period of contract.
- 33. No interest will be paid to you if the payment is delayed from this office.
- 34. In case of deficiency of services a penal charge @ 1000 per day for per person will be deducted from the payment.
- 35. The agreement has been entered into for a period of 01 Year and renewal will be subject to satisfactory service. However, the agreement can be terminated by the Department if the service is not found satisfactory by giving 30 days notice in advance to the vendor. Similarly, the vendor can also terminate this agreement by giving notice in 30 days in advance to the Department. The Agreement may be renewed based services of the vendor and good conduct of staff.
- 36. Any other matter during the period of this agreement, which has not been specifically covered by this agreement, shall be decided by the Department, whose decision shall be final and conclusive.
- 37. All disputes arising out of this agreement shall be subject to jurisdiction of the local court.
