The deputation will be governed by the terms & conditions as contained in the DOP&T'S O.M.No2/29/91/Estt(PayII) dated 05.01.1994 and No.6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding his/her appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

The official selected can opt to draw the grade pay of the post for which he is selected or his pay plus deputation allowance (10% of his basic pay in case of outstation officials and 5% for local officials, subject to maximum of Rs.9,000/- and Rs.4,500/- respectively as per 7th CPC and as per revision of Dearness Allowances).

The applications from suitable candidates who are willing and eligible in terms of the above criteria may be duly certified and forwarded to this office along with their bio-data in the prescribed form (Annexure-I), so as to reach this office **not later than 30.04.2026**.

The photocopies of the ACRs / APARs of the applicants for the last 5 years duly attested along with Integrity Certificate, Vigilance Clearance Certificate and Certificate showing that no major/minor penalty was imposed during the last 10 years may also be sent along with the application.

The applicants who volunteer for the post will not be permitted to withdraw their names at a later date and only such applications which are duly forwarded by the concerned office through proper channel and accompanied by the ACRs / APARs along with Vigilance Clearance, etc. will be considered.
